Resolution 199 - Resolution to Declare a Seat Vacant

WHEREAS, NYS Ed. Law, Art. 52-A, § 2590 provides that a member of a community district education council who refuses or neglects to attend three meetings of such council of which he or she is duly notified, without rendering in writing a good and valid excuse therefore vacates his or her office by refusal to serve; and

WHEREAS, the law further provides that, after the third unexcused absence, the community council shall declare a vacancy to the chancellor; and

WHEREAS, all members of Community Education Council 30 have been duly notified of all scheduled Calendar and Business Meetings for the 2025-2026 School Year, as the meeting schedule voted on and adopted at the July 14, 2025 Calendar and Business Meeting, and has been posted on www.cec30.org since July 15, 2025; and

WHEREAS, the subsequent meeting notice is also announced to members and the public in attendance by the Co-President(s) at the conclusion of the current month's Calendar and Business Meeting; and

WHEREAS, Council Member Nahounha Alexandre has, without providing a prior excuse in writing, missed the following Calendar and Business Meetings as listed below:

WHEREAS, on December 11, 2025, Council Member Alexandre was duly notified via email that “if you do not attend the January meeting and fail to provide written notice beforehand, you will receive formal notice that you have vacated your seat on CEC 30.”; and

WHEREAS, due to lack of a written notice and failure to attend the January 12, 2026 Calendar and Business Meeting, CEC 30 members held a vote regarding Council Member Alexandre’s absences, which resulted in a unanimous vote that the third unexcused absence had in fact occurred, and to move forward with the sending formal “Notice of Intent to Vacate Your Seat” as prescribed in the December 11, 2025 email; and

THEREFORE BE IT RESOLVED THAT CEC 30, hereby declares to the Chancellor that a vacancy exists on the council; and

THEREFORE BE IT FURTHER RESOLVED THAT CEC 30, upon adoption of this resolution, will publicly advertise and subsequently fill the vacancy in accordance with Chancellor’s Regulation D-140.
